IV. STANDING COMMITTEE REPORTS

- Trustee Brewton BCM Foundation is hosting a Pop up June 13, 2021 from 2-6pm at the Elks Lodge in Crestwood.
- Paul Rayon explained the 1st month if service are used to develop a strategy to locate hotspots, take pictures of abandoned homes and yard debris.
- Contact toll to take care of area by I-294 ditch.
- Rayon services the village on every Tuesday from 9am-2pm
- Services are divided into zones 1-4 Zone 1 K Town (west of Pulaski)
- Zone 2- middle of 135th to Central Park
- Zone 3 all municipal buildings
- Zone 4 Manny's to Richard Flower Homes
- Zone 5 Village to Kinne Rd. to Midlothian
- Mr. Rayon stated boxes are monitored for activity, and the poison is locked inside bait box.
 Pictures are captured and stations are put in place.
- Public Safety: Chair Trustee Robinson met with fire dept. Goals of the fire dept. are looking to hire full-time staff and ambulatory service.
- Interim Chief Lackland, Interim Deputy Sargent Redmond, lock box in both departments
- Fire dept. offering EMT training \$50 for 2 days a week. Ride alongs with police dept. to observe operation will continue.
- Transportation: Trustee Robinson will participate on June 10 via zoom for the Pulaski Road Corridor Study 159th - 127th street, study to evaluate transportation needs. Looking at an ordinance for Parking along Central Park Pace bus zone. Wheelchair van and bus for seniors
- Public Works: Chair Trustee Collier; There is a dire need for employees in the public works dept.,
 bilingual workers are also needed. Applications are located at the village hall.
- The majority of village equipment is being leased, will check will lease is up
- Trustee Collier stated that he wanted to purchase a trailer for \$5,325. He will go back before the committee with more details before final approval.
- Signs where houses were demolished are being removed and the fields cut
- Sewage machine is up and running
- Finance: Trustee Brewton advised adjustments made to appropriations and purchasing manual.
 Discussions were made in earlier Finance Committee meeting

A. ACCEPT WARRANT LIST

B. PLANNING AND ZONING BOARD

Mayor made a correction (added Warren Madkins, removed Bernard Ward) to Planning and Zoning list. Clerk Dyson swore in new members of the Planning and Zoning Commission. It was moved by Trustee Dyson and seconded by Trustee Collier to accept the planning and zoning board

- C. Community Service Officers (CSO's) Trustee Robinson explained that this program will be similar to the one in Crestwood, where citizens are in uniform, but not police officers, to give input and help as part of community policing. Mayor said it needs to be moved back to committee for further discussion
- D. SPEED BUMPS: Trustee Brewton stated that discussion was made during committee meeting on criteria to determine where and the type of speed bumps to be installed in the village
- E. SUMMER JOB PROGRAMS FOR THE YOUTH: Mayor spoke about establishing a youth commission board. It will be called YAC-Youth Advisory Committee, which will review and prioritize issues concerning the youth and make recommendations for their health and well-being. There is no tentative start date, and made the recommendation to ordinance and license committee for further discussion
- F. WALK & ROLL FOR LOVE: Administrative Asst. Washington spoke about this tentative event, which came about because of the recent gun violence in the community. The tentative date is set for July 10th. They are working to determine the route, which will consist of walkers and persons on bikes, etc. (no cars) and bring to the board for approval
- G. APPROVAL OF PURCHASE FOR PUBLIC WORKS TRAILER: Trustee Collier said there is a dire need in the public works department for a trailer. There is one in Wisconsin for the cash price of \$5325.00, someone would have to go pick it up. Trustee Maxey made a motion to defer item back to committee, it was seconded by Trustee Collier. H. AZAVAR

Tom Fagan made a presentation from Azavar, which is a company that helps municipalities make sure they are getting all the revenues that are due them from companies such as AT&T, ComEd, Comcast, etc., by making sure addresses are coded correctly. It would be on a contingency basis for 36 months, with 55% to the village and 45% to Azavar (this is negotiable). He stated Mayor's assistant had power point presentation for board review.
