AN ORDINANCE AUTHORIZING THE ACQUISITION OF DONATED VEHICLES FROM THE CITY OF MARKHAM, ILLINOIS

WHEREAS, the Village of Robbins (the "Village") Is a home rule unit of government pursuant to Article VII, Section 6 of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the Village needs to acquire two vehicles in order to maintain services in the Village; and

WHEREAS, the City of Markham, Illinois desires to donate two vehicles to the Village. Those vehicles are two Ford Escape Sport Utility Vehicles. (the "Vehicles"); and

WHEREAS, the President and the Village Board (collectively, the "Corporate Authorities") have determined that it is necessary and in the best interests of the Village to authorize and approve the acquisition of the Vehicles;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Robbins, Cook County, Illinois, by and through its Home Rule Powers, as follows:

Section 1: That the above recitals are incorporated herein and made a part hereof, as set forth in their entirety.

Section 2: The Corporate Authorities hereby authorize and approve the purchase of the Vehicles, as set forth in the preamble. The Corporate Authorities hereby further authorize and direct the President to execute and ratify the execution of all necessary documents and perform all necessary acts to effectuate the intent of this Ordinance and to authorize and direct the expenditure of all costs related thereto or resulting therefrom. To the extent that the purchase of the Vehicles is subject to competitive bidding requirements, the same is hereby waived.

Section 3: The officers, employees and/or agents of the Village shall take all action necessary or reasonably required to carry out and give effect to the intent of this Ordinance and shall take all actions necessary in conformity therewith.

Those actions, include, but are not limited to executing any and all documentation required to acquire the following vehicles:

Car #1 - Ford Escape. VIN 1FMCUO2Z18KC07912 Car #2 - Ford Escape. VIN 1FMCUO2Z28KC07417

Section 4: If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

Section 5: All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 6: This ordinance shall be in full force and effect on __March 28__, 2023 after its publication in pamphlet form.
