AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2022, AND ENDING DECEMBER 31, 2022, FOR THE VILLAGE OF ROBBINS, COUNTY OF COOK, STATE OF ILLINOIS.

WHEREAS, the Village of Robbins (the "Village") is a duly organized and existing municipality and a home rule unit of government pursuant to Article VII, Section 6 of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the Village Mayor (the "Mayor"), the Honorable Darren E. Bryant and the Village Clerk, the Honorable Sharon S. Dyson (the "Clerk"), and the Board of Trustees of the Village (the "Village Board"), the Honorable George Brewton, David R. Dyson, Tiffany S. Robinson, Gregory N. Jackson, Michael D. Collier, Sr. and Ernest Maxey, Jr. (together, the "Corporate Authorities"), constitute the duly elected, qualified and acting officials of the Village; and

WHEREAS, the Corporate Authorities have previously determined and do hereby determine that the amounts of money specified herein, exclusive of any cost of conducting an election required by the general election law, are estimated to be necessary to be raised by taxation upon the taxable property in the Village; and

WHEREAS, Section 18-60 of the Truth in Taxation Law (35 ILCS 200/18-60) requires the corporate authority of each taxing district to estimate the amounts of money necessary to be raised by taxation for that year upon the taxable property in its taxing district. The Corporate Authorities deem it in the best interest of the Village to estimate the Village's aggregate tax levy for the tax year 2022; and

WHEREAS, the Corporate Authorities have determined and do hereby determine that it is advisable, necessary and in the best interest of the Village to levy and assess taxes for the fiscal year beginning January 1, 2022, and ending December 31, 2022, to be collected in 2023; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Robbins, Cook County, Illinois, by and through its Home Rule Powers, as follows:

**Section 1: Incorporation**. All of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true, and correct, and the Village Board does hereby, by reference, incorporate and make them part of this Ordinance as legislative findings.

**Section 2: Purpose.** The purpose of this Ordinance is to approve the levy and assessment of taxes for the fiscal year beginning January 1, 2022, and ending December 31, 2022, for the Village.

**Section 3: Authority.** This Ordinance is adopted pursuant to the authority granted to the Village by the Constitution of the State of Illinois and the Illinois Compiled Statutes.

Section 4: Total Amount of Appropriations to be Collected from Tax Levy. That the total amount of appropriations for all corporate purposes legally made to be collected from the tax

levy of the current fiscal year is hereby ascertained to be the sum of Two Million, Twelve Thousand, One Hundred and Sixty-Four and U.S. Dollars (\$2,012,164).

Section 5: Purposes Provided For. That the sum of Two Million, Twelve Thousand, One Hundred and Sixty-Four and U.S. Dollars (\$2,012,164) being the total of appropriations heretofore legally made which are to be collected from the tax levy of the current fiscal year of the Village for all corporate purposes of said Village, for purposes of providing for Corporate, Bonds and Interest, Garbage, Police Pension Fund, Fire Pension Fund, Illinois Municipal Retirement Fund, Street and Bridge, Police Protection, Fire Protection, Auditing, Liability Insurance, Street Lighting, Judgment Fund, Workmen's Compensation, and Water and Sewage as appropriated for the current fiscal year by the Budget Ordinance of the Village for the year 2022, passed by the Corporate Authorities at the meeting to be legally convened in April 2022 and the same is hereby levied upon all of the taxable property in the Village subject to taxation for the current year, the specific amounts as levied for the various funds heretofore named being included herein by being placed in separate columns under the heading "Amount To Be Raised From 2022 Tax Levy," which appears over the same, the tax so levied being for the current fiscal year of the Village, and for the said appropriations to be collected from said tax levy, the total of which has been ascertained as aforesaid and being as provided in the "Village of Robbins, Illinois 2022 Property Tax Levy," a copy of which is attached hereto and incorporated herein as "Exhibit A" as if fully set forth herein.

**Section 6: Amount Levied.** That the total amount of Two Million, Twelve Thousand, One Hundred and Sixty-Four and U.S. Dollars (\$2,012,164) ascertained above, be and is hereby levied and assessed on all property subject to taxation within the Village according to the value of said property as assessed and equalized for state and county purposes for the current year.

Section 7: State Authority to Adopt Ordinance. This Ordinance is adopted pursuant to the procedures set forth in the Illinois Municipal Code; provided, however, any tax rate limitation or any other substantive limitations as to tax levies in the Illinois Municipal Code in conflict with this Ordinance shall not be applicable to this Ordinance pursuant to Section 6 of Article VII of the Constitution of the State of Illinois. All applicable provisions of the Illinois Compiled Statutes, including the Illinois Municipal Code, as may be amended from time to time, relating to the purposes of this Ordinance are hereby incorporated herein by reference.

**Section 8: Certification of Levy.** That there is hereby certified to the Cook County Clerk of Cook County, Illinois, the total amount of Two Million, Twelve Thousand, One Hundred and Sixty-Four and U.S. Dollars (\$2,012,164) which total amount the Village requires to be raised by taxation for the current fiscal year of the Village, and the Village Clerk is hereby authorized and directed to file with the Cook County Clerk, on or before the time required by law, a certified copy of this Ordinance.

**Section 9:** Headings. The headings for the articles, sections, paragraphs, and subparagraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provisions of this Ordinance.

**Section 10:** Severability. The provisions of this Ordinance are hereby declared to be severable and should any provision, clause, sentence, paragraph, subparagraph, section or part of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision, clause, sentence, paragraph, subparagraph, section or part shall be excluded and deemed inoperative, unenforceable and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect. It is hereby declared to be the legislative intent of the Village Board that this Ordinance would have

been adopted had not such unconstitutional or invalid provision, clause, sentence, paragraph, subparagraph, section or part thereof been included.

**Section 11: Superseder.** All code provisions, ordinances, resolutions and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

**Section 12: Publication.** A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

**Section 13: Effective Date.** This ordinance shall be in full force and effect immediately upon its publication in pamphlet form.
