#### A. Mayor's Report

Darren E. Bryant

- The Mayor thanked the Park District for inviting him out to the Senior luncheon today, he had a blast with the seniors. He spoke with them about 7 million dollars in limbo in Springfield, 5 million of which is earmarked for capital improvements. He needs the community's help in getting those funds for the village. We were awarded \$739,000 from the American Recovery Plan on the federal level, it will be given in two installments. The first should be given sometime next month.
- We have been approved for \$1.4 million for street resurfacing and things of that
  nature for next year. It's a good time for the board to decide how the CDBG funds
  should be spent and what projects should be handled first.
- The Robbins bulletin is now created and you can get the latest news in the village as well as see my vision for the community. We know that Channel 4, which was the community media channel is not working, but we are working to be our own media voice.
- Senior advisory committee: sign up sheet is available at the village hall. I want to be in touch with the wisdom from the seniors and am looking to meet once a month to discuss plans for the village.
- Publicly want to thank Kyiesha Hill for her efforts on the community garden. Please go and visit and support the garden, it's a sight to behold with fresh fruits and vegetables.

## IV. STANDING COMMITTEE REPORTS

Police Department Report: Trustee Maxey

- Public Safety/Transportation: Chair Trustee Robinson announced IDOT has a funding opportunity with a grant for SRT (safe route to school) and she is actively seeing how to get that grant for the village. Also, we have the list of the streets with the deep potholes that citizens have concerns about. We will do light patchwork for now.
  - b) Citizens will get to hear from Dan Murdock regarding the license plate readers Actively looking for a new Police Chief. Reminded citizens the police department is a cooling center in light of the upcoming warm weather.
  - c) Over the next few weeks, the committee will be working on drafting a curfew ordinance. We have one presently, but it doesn't have any content and with the activity going on in the village a new one is needed. We will give the citizens a 30 day notice before it's enforced, because there will be fines associated with it
  - d) Thank you to Ryan for being our assistant and helping the board each week. He helped review ordinances and is looking forward to working with the board to update ordinances to move the village forward.

Mayor advised that public works has started filling in some of the potholes. Reminded citizens the speed limit for the school area is 10 miles per hour and to please slow down.

- Public Works: Chair Michael Collier reminded citizens if they have concerns to please either call the Water department or come to the village hall and fill out the form.
   He is having a coffee with the Trustee meeting on Saturday August 14th from 10am-11am
- Finance: Chair Trustee Brewton advised that the board is in support of Tom Fagan from Azavar and will recommend it come to the next board meeting for approval.
- Public Property: Chair Trustee Brewton, he wants to call a meeting at 5:30 pm before the next council meeting.
- License and Ordinance: Chair Trustee Dyson spoke about the meeting last Thursday regarding the youth initiative, still a work in progress. We discussed Municode, a system that codifies our ordinances. In conjunction with Mr. Fagan's work, we may be missing out on funds because of outdated ordinances.

B. Dan Murdock of Flock Safety made a presentation regarding license plate reader that can be beneficial to the village to deescalate crime. Flock Safety is the largest vendor in the state and has been in business for 5 years. After questions from the board and citizens, Mr. Murdock clarified cost details of the contract: 60 day trial period at no cost to village for 5 cameras, after

that it will be a 2 year contract of \$13,750 ( $$2500.00 \times 5$  camera and \$250.00 x 5 implementation fee for first year) and \$12,500 for second year.
