ORDINANCE NO. 12-14-21

**AN ORDINANCE ADOPTING A NEW VILLAGE SEAL
IN THE VILLAGE OF ROBBINS, COOK COUNTY, ILLINOIS**

WHEREAS, the Village of Robbins is a home rule unit by virtue of the provisions of the constitution by the State of Illinois; and

WHEREAS, the Village of Robbins, as a Home Rule unit, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the Mayor and Board of Trustees find that the current Village Seal for the Village of Robbins does not represent the achievement of community spirit; and

WHEREAS, pursuant to statute, 65 ILCS 5/2-3-8, a Village may change its corporate seal at its pleasure; and

WHEREAS, the Mayor and Board of Trustees have determined that it is in the best interests of the Village to adopt a Village Seal which represents the true history of the Village of Robbins.

NOW, THEREFORE, be it ordained by the Mayor and Board of Trustees of the Village of Robbins, Cook County, Illinois, as follows:

Section 1: The foregoing recitals are hereby incorporated into this Ordinance No. 12-14-21 as if fully set forth herein.

Section 2: The Village of Robbins hereby adopts as its official seal:

Section 3: All ordinances or portions of ordinances previously passed or adopted by the Village of Robbins that conflict with or are inconsistent with the provisions of this Ordinance are hereby repealed.

Section 4: This Ordinance shall be in full force and effect from and after its passage and approval.




