- VANESSA ROBINSON STATED SHE USED TO DO THE SENIOR BRUNCH AND WANTS TO KNOW IF THEY CAN USE THE FORMER CEDA BUILDING TO RESUME THAT. SHE ALSO STATED SHE WOULD LIKE FOR THE PROGRAM THAT RECOGNIZES SENIORS OVER 90 YEARS OLD TO CONTINUE.
- LADONNA LYMON, AGAIN CONGRATULATED THE NEW ADMINISTRATION. SHE STATED HER
 CONCERN ABOUT A TREE THAT IS TOWERING OVER AND TOUCHING THE ROOF OF HER
 MOTHER'S HOME AT 13747 ST. LOUIS. SHE SAID THE VILLAGE HAS BEEN AWARE OF THIS
 PROBLEM FOR YEARS AND HOPES SHE CAN GET SOME ASSISTANCE WITH GETTING THIS TAKEN
 CARE OF. TRUSTEE COLLIER WILL LOOK INTO IT.
- MRS. BOLTON STATED HER CONCERN ABOUT THE LACK OF LIGHTING ON CENTRAL PARK BY THE LIBRARY. SHE ALSO ASKED THAT THERE BE HAND SANITIZER AVAILABLE AT THE NEXT MEETING
- BARBARA PARHAM VOICED HER CONCERN ABOUT HER WATER BILL, STATED IT'S JUST HER AND HER SON WHO LIVES IN THE HOME AND SHE GOT A BILL FOR \$50 MORE THAN ANY OTHER TIME. SHE STATED SHE HAS ALWAYS PAID THE SENIOR RATE.

- MYRNA RATLIFF STATED HER CONCERN THAT THE VILLAGE IS FILTHY, TOO MANY OLD CARS,
 GARBAGE BEING LEFT. SHE SITED 13628 TURNER AS ONE PLACE IN PARTICULAR. AS WELL AS
 CLAIRE & KEDZIE. SHE FEELS PEST CONTROL WON'T HELP IF THE VILLAGE ALLOWS THE CITIZENS
 TO HAVE ALL THIS JUNK AND GARBAGE LYING AROUND.
- LULA FULSON ASKED IF WE HAVE A CODE ENFORCEMENT OFFICER. SHE WAS ADVISED THE VILLAGE HAS TWO (2).
- MR. REED STATED HE HASN'T BEEN IN THIS BUILDING SINCE MAYOR BRODIE WAS IN OFFICE
 AND IT'S AN EYESORE, NEEDS RENOVATION. ALSO SAID HE WAS CONFUSED BY THE
 TREASURER'S REPORT, WASN'T SURE IF WE DOING WELL OR IN TROUBLE. HE ALSO SAID HE
 WAS CONFUSED BY THE DIFFERENT COMMITTEES AND WANTED TO KNOW IF CITIZENS CAN BE
 A PART OF THEM.

MAYOR REPLIED THAT THE VILLAGE HAS APPLIED FOR CAPITOL BUILDING FUNDS FROM SPRINGFIELD IN . THE AMOUNT OF \$3.5 MILLION. HE WILL GET DESCRIPTIONS OF WHAT EACH COMMITTEE DOES.
