Mayor stated he is making the decision to have a water meeting next Tuesday at 6PM Gilbert Shepherd thanked the mayor for the work being done in the village, his side of town has been neglected. He doesn't mind the demolition, as long as they leave the debris neat. Ms. Ward asked what is the status of the community center? Stated she is the one that called the Dept. of Health about the conditions

Ms. Williams asked is there mold on the 2<sup>nd</sup> floor of the community center? Rave Ramsaran said he can see changes in the community.

Ms. Fulson asked can a repast be held at the community center now?
