Requirements:

Section 1. Hours of Operation

- I. Tag Days are permitted on Saturday or Sunday between 9:00 a.m. and 3:00 p.m. Tag Days are not permitted Monday – Friday with exception of the Fire and Police Department.

Section 2. Permit and Fee

- I. It shall be unlawful for any person or solicitation organization to participate in Tag Day without first securing a permit.
- II. Each permit shall be valid for only one consecutive Saturday or Sunday per year; provided, however, in the event of inclement weather during any such day, the Village Administrator or Assignee shall assign the person to whom the permit applies an alternative day;

Section 3. Age Restriction

- I. It shall be unlawful for any person, firm or corporation to allow any person under the age of sixteen (16) years of age to participate in Tag Day.
- II. Solicitor must wear reflective high visible vest when participating in Tag Day.

Section 4. Solicitation upon the public streets

- I. Solicitation is allowed only on 139th & Claire Blvd. intersection
- II. Solicitation shall occur during the hours of daylight.
- III. Solicitation is not permitted during clement weather.
- IV. Solicitation is not permitted during the months of November through March.
