AN ORDINANCE AMENDING ORDINANCE 12-9-03, AN ORDINANCE REGULATING VEHICLE LICENSES IN THE VILLAGE OF ROBBINS, COOK COUNTY, ILLINOIS

Now, Therefore, be it Ordained by the Mayor and Board of Trustees in exercise of its home rule powers as follows:

Amendment of Code: Chapter 14 of the Code of Ordinances of the Village of Robbins shall be amended to read as follows:

Section 14-181

Definitions

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Motor vehicle means every self-propelled device in, upon or by which any person or property is or may be transported or drawn upon a highway except devices moved by human power, unless the context clearly indicates otherwise.

Section 14-182

Required

No person residing in the village, nor any firm or corporation having its principal place of business in the village shall use, cause or permit any of his or its agents or employees to use any motor vehicle in the transportation of persons or property or the conveyance of loads upon the streets, avenue or alleys of the village unless such motor vehicle is licensed as provided in this article; and further, that any vehicle to which a license is issued by the state at a private place of residence or business in the village shall be required to be licensed as provided in this article.

Section 14-183

Application, issuance

Every owner or operator of a motor vehicle or motor bicycle desiring a license for a vehicle as required in section 14-181 shall file an application with the Village Clerk, upon a form to be provided by him/her, setting forth the name and address of the applicant and a description of the vehicle for which the license is desired.

Fees

a) Annual fees for motor vehicles: The license fee for each motor vehicle to be paid annually to the Village Clerk shall be as follows:

All vehicle tag or sticker licenses shall be valid for a one-year period beginning January 1 and ending December 31. Vehicle sticker fees are non-refundable.

For newly purchased vehicles, or new residents, the owner shall have one month (30 days) from the date of purchase, or residency, to buy a vehicle sticker at the above-enumerated rates. The penalty amounts shall be added for either newly purchased vehicles or new residency, if not purchased within the specified 30 day timeframe.

- b) Senior citizen rates: The license for each private passenger vehicle for persons 65 years or older shall be \$20.00 per year. A maximum of two (2) senior citizen rate stickers per household with two different individuals are allowed. Further, the applicant(s) shall be required to submit satisfactory proof of age by way of birth certificate, drivers license or Medicare card.
- c) Handicap/Disabled rates: The license for each private passenger vehicle who is handicapped/disabled shall be \$20.00 per year. Only Handicap Plates documentation will be accepted. Placard will not be honored.

Section 14-185

Allocation of fees

The proceeds of the fees referred to in section 14-184 shall be used in such a manner as the mayor and board of trustees shall direct.

Section 14-186

License Tags

a) Upon the issuance of an application, the Village Clerk or his/her designee, shall deliver to the applicant a vehicle tag or sticker upon which shall appear the words "Robbins, Illinois" and a number identical with the number of such license and year for which such license is issued.

- b) The applicant shall affix the vehicle tag or sticker to the lower right hand corner of the vehicle windshield, or if there is no windshield, then in a conspicuous place upon such motor vehicle, where it can be readily seen.
 - **Exception**: EA vehicles shall not be required to display tag or sticker on windshield, but shall have it available upon request by law enforcement.
- c) No motor vehicle although duly licensed shall be used upon the streets, avenues or alleys of the village unless such tag or sticker is attached thereto.
- d) Any person who fails to exhibit a vehicle tag or sticker shall be fined a fee of \$50.00. Payment of late penalties shall not exempt a person from any other fines imposed for the operation of a motor vehicle without the display of a proper sticker.

Sale or Transfer

Immediately upon the sale of any motor vehicle which has been theretofore licensed, as provided in this article, prior to the date of such sale or transfer, the vendor or transferor shall remove the license tag or ticker from the motor vehicle so sold or transferred, and the license so issued for such motor vehicle from such date, and the purchaser or transferee thereof, shall immediately apply to the Village Clerk for a new vehicle tag or sticker, as above provided. Upon showing to the Village Clerk that such tag or sticker has been so removed from such sold or transferred vehicle and the payment of a transfer fee of five dollars (\$5.00), the Village Clerk or his/her designee may issue a new tag bearing a new number, which shall apply to and be assigned to any other vehicle, new or used, of the same class owned by such vendor or transferor; except as above provided, no tag or sticker issued for or assigned to any motor vehicle shall ever be used for or attached to or upon another and different motor vehicle. Transfer of a tag or sticker is allowed one time only during the year.

Section 14-188

Effective Date

That the Village Clerk shall certify to the adoption of this ordinance, and case the same to be published as required by law: and this ordinance shall take effect and be in force immediately after passage.
