Two grants are being worked on: CDBG for \$400,0000, and one for Invest in Cook Street repaving should begin next month, excited about Lincoln Lane because it has been neglected for a long time.

The village planner has made some preliminary plans for Zone 2, but he's not satisfied with those plans and sent them back to be reworked before presenting to the board and public.
