#### C. Treasurer Report

## IV. STANDING COMMITTEE REPORTS

- Public Safety: Trustee Robinson thanked all involved in contributing with donations to the Labor Day Parade. The public safety committee will be submitting to the attorney a request for an updated curfew ordinance. This will be enforced, and a \$100 fine will be issued for minor children in violation of this ordinance. Reminder that the Police station and Park district are cooling stations. We are still in search for a Police Chief. Trustee Robinson stated that they are identifying the five areas to put the Flock license reader cameras.
- Public Property: Trustee Brewton is working on a scheduling a meeting on 9-21-21 to be a working committee meeting, where they will go out in the field and look at all the Village owned properties to develop an action plan.
- Public Works: Trustee Collier commended the Public Works Department for the work they've done with minimal workers. Supervisor Melvin Wells submitted a 4-page update on what work the department has completed. There are 2 dumpsters full of debris and are working hard to keep the Village clean. If you have a concern, please call the Village Hall and report findings.
- Water Dept.: Trustee Collier urged citizens to pay water bill as notices will be going out, and disconnections will be in effect soon. Please come in and work out a payment arrangement if necessary. As of April 1, 2021 the restriction for utility cut off was lifted.
- Building dept.- Trustee Dyson is moving or an initiative that can help citizens winterize
  their homes, as well as do minor repairs in maintaining their homes. Spoke with
  representative from Congressman Rush's office on getting assistance with this
  endeavor, so that older homes are brought up to date with newer developments.

don't have an ordinance on loitering and need to consider creating an ordinance. She will
take it back to the License and Ordinance committee and submit a request to adopt an
ordinance for loitering.

  - Louis Henderson wants to purchase 3 vacant lots on Springfield and does not feel
    that he should pay \$240.00 per pin for an inspection on a vacant lot. Todd Stroger
    instructed him to see him after the meeting was over. Trustee Brewton informed
    him that as of now it is the present law of the land.
  - Thelma Ellis asked, what is the curfew ordinance and what does it state. Trustee Robinson explained
  - Mr. Harper asked if loitering ordinance for all ages. Trustee Robinson explained.
  - Mr. Bolton asked is staffing levels being discussed in Public Safety meetings. Trustee Robinson explained that manpower and compensation are not where it needs to be.
