Tag Days are permitted on Saturday or Sunday between 9:00 am and 3:00 p.m. Tag Days are not permitted Monday through Friday with exception of Fire and Police Department.

Each permit shall be valid for only one consecutive Saturday and Sunday per year; provided, however, in the event of inclement weather during any such day, the Village Administrator or Assignee shall assign the person to whom the permit applies an alternative day.

It shall be unlawful for any person, firm or corporation to allow any person under the age of sixteen (16) years of age to participate in Tag Day.
