I. STANDING COMMITTEE REPORTS

Trustee Robinson- Public Safety- Flock cameras trail ends on January 15, 2022 and would like the board to bring it back to discuss and approve to keep system in place.

Fire – the ceiling has been repaired by Anton Sykes who removed old installation and replaced with new installation and drywall. The firehouse had a COVID deep clean by CSI. DC Malley submitted check request for the lettering of new fire truck. Thank you to the Mayor and Wells for answering the walker ladies' questions. Carrie Smooth of 3711 Maxey Court stated she was grateful the public works dept. picked up the tree branches, but they rode over the grass and left deep tire tracks.

DC Mallley Sr. contacted Walsh regarding the ambulance repair quote. Spoke with Mia, who advised they were checking it out and she would contact once they did a full look over.

Fire Prevention Smoke Detector Program for the community which is being spear headed by Engineer Jones.

Street signs-can we canvass the village to make sure all signs are in place such as street, stop signs and other signs that me be removed from its original place.

We are going to be implementing the Municipal Tow Ordinance within the next two weeks.

We have reached out to our attorney regarding this ordinance.

Licenses: Within the village we have some businesses that may require multiple licenses. We will be making sure that the businesses have the required number of licenses. For example, the gas station should have multiple licenses if they are selling gas, food, lottery, clothes, etc. Each entity requires a different license.

Mayor- as of Jan 4th, every residence should have received a new garbage can according to the app. Tri-State should be out tomorrow to retrieve cans. If there is still a Tri-State tote on Thursday and Flood brothers will pick up trash. Residents who purchased additional cans, those are marked with a yellow sticker, Flood brothers will honor those cans and empty them.

Trustee Collier- Public Works- we were low in on salt, did a decent job with what they had. Mayor working on getting more trucks to be more self-sufficient. Trustee Maxey- asked if Flood brothers will empty all the totes even if they are not Tri-State totes? Mayor stated that his understanding is yes but will bring them out for Thursday's meeting to answer questions.

Lula Fulson- was the money issue with the police resolved? Did they get a raise? Is anyone in the village getting a salary of \$80,000/ \$85,000 per year?


