# III. ADMINISTRATIVE REPORTS

A. Mayor's Report-Congratulations to Robbins own, wrestling Champ Justin "JUJU" Harris, is here and is pleased to have him be recognized in front of the community. Feels good to be the champ, his dad stated that it was not easy to be the champion and the best in the state of Illinois. Four other children competed, and they enjoyed the time outside the competition to create good memories.

MWRD scheduled to close bid end of March, winner announced in April, due to begin project in May. Special shout out to Senator Jones and Representative Bob Rita for efforts in helping to bring unity to Village, many things in store. Currently applying for CDBG grant and Invest in Cook transportation grant. Streets to be resurfaced are the following: Finley, Glenn, Wayman Ln., Richardson Ave., and Lincoln Lane, these streets chosen by the engineering firm. Lawndale, 141st and 142nd street will be repaved next month, April. The building department has begun tagging homes for demolition. The Village is currently hiring for an administrator and grant writer positions, please visit Village of Robbins website to apply. To citizens Praise God, enjoying the process and a new season is upon us.

- B. Clerk's Report- \$750 collected for transfer stamps. 218 senior stickers sold totaling \$4,360, 265 vehicle stickers sold totaling \$7,811, 48 truck stickers sold totaling \$2,100 and 1 motorcycle sold totaling \$26.00. The clerk's office is working to update ordinances and scheduled fees. Business license updated next month, all business owners be on the look-out for updates and the issuance of new licenses.

## IV. STANDING COMMITTEE REPORTS

Trustee Collier- public works & water- water updates and procedure have been revised for payment arrangements, and disconnect notices to be presented to the mayor. Missing street signs have been identified, list created and working on bids to get signs replaced. Mayor reminds committee to become self-sufficient was a goal for the department and that in the months to come prepare with necessary quotes for equipment to move forward. Trustee Robinson- Happy Women's history month, congratulations to Juju the Champ. Jermaine Harris will compete in May, in Florida for the National Cheer championship. Public safety will be moving in a different direction to address homeland security needs for the Village. Reach out to Mr. Madkins to discuss active shooting training. Introduction to new CSO officer Vladimir Benson, thanks Ryan for pushing the initiative to implement CSO officers. The start date for the police academy is pending. The department is being built and the presence of RPD is being seen in the community with 29 officers in the department. updates need regarding licenses and ordinances. Fire report- read by Lt. Bollinger: Feb 101 reported incidents; 77 medical emergencies, 14 fires, 5 motor vehicles, 5 hazardous materials. One new member, two are in the final steps, hopefully by the end of the month. Currently accepting applications, fee is \$25 per application and they can be picked up and paid for at Village Hall. Tower ladder is out of service, has been taken to shop and obtaining a second quote.

Trustee Jackson-Transportation- gas prices are at a high and will be raised even more, reminds residents that alternative transportation such as Bremen township senior ride, Pace, Metra, and ride share can help alleviate expenditures for gas. Meeting tomorrow to work on a ride program for the village.

Trustee Brewton – Finance- Urges board to be aware that appropriation is coming soon and wants Mr. Kemp to prepare board to make an informed decision.

Mayor stated that we have been appropriating blindly, Mr. kemp working with each department to get individual budget and will look at revenue to help adjust appropriation. Administration will have it to the board within the current month.
