Ron Smith with Robinson Engineering called in to explain the process of the project it was advertised in local newspaper, two minority contractors picked up bid packets, but did not submit a bid for the project. Clerk opened bids to lowest most responsive bidder and Mr. Smith made recommendation to board with regards to the project. The village received \$400,000 for CBDG project, during the bidding process bids came in \$422,000 and \$410,000 the lowest most responsive. Never bid project at lowest bidder amount an \$20,000 of grant funding that would not be used. Bids are padded so that there's extra we will make sure that \$400,000 and village is not going to be responsible for overages. Quantity are now 1-3% of what will be done they are padded so that the contractor doesn't go over the amount. This is done so that all grant funding is used from the project. Trustee Collier asked if bidder bid at \$410,000 will they receive \$410,000 Village reserves the right to increase or decrease, no legality, contractors are familiar, and we have budgeted amount that will be spent. Meeting is for Smith, the mayor, and administrator to meet with Gallagher the lowest bidder and discuss what is for the layout of what the project will entail.
