For those that are here tonight and haven't signed up, there are forms in the back, please fill it out and return to us. By signing up, you will get a text to advise you if there is an emergency or water shutoff, etc. During the recent water outage, we signed up approximately 75 citizens.

The Robbins Fire Department will be able to assist residents with getting free smoke detectors installed in their homes. If you are not able to complete the form online that is listed on the Village website under the Fire Department tab, please contact the building Department for assistance.

Robbins Friends of the park and the park district will have their annual back to schoolbook bag giveaway on Saturday, August 12, from 1-4pm. There will be entertainment and refreshments. One backpack per child and the child needs to be present.

There is a 3-day public safety challenge, Aug 8-10 from 10am-3pm, for ages 11-17, 3323 W. 137th St. An opportunity for kids to come out, have fun, earn community service hours and get involved in the community.

There will be work done by Nicor and Mead Construction beginning this evening at 139th & Springfield, until Saturday. You will not be able to go west on 139th pass Hamlin, or east/west on Springfield.

III. A. Mayor's report: Congratulations to the Robbins Eagles on their 40th year. He showed a rendering of the proposed recreation site at 135th & Claire. This past Saturday, there was a meeting to critique the mayor's performance to date. Thankful for the feedback, and he will have it posted online soon. Packet was available tonight.

Gave an update about the water problems experienced over the last few weeks. The village issues are on the governor's desk and we're hoping to get the \$4 million released soon. The \$1 million has been received for the municipal building, must put out RFP to get project started. Hope to get \$2 million for lighting this fall.

Administrator's report: thanked everyone, the citizens, staff, trustees for all the help and patience during these water outages. Gave report about the audit preparation, reconciling payroll processes (two years to go), citizens provided written report.

Public safety meeting will be Thursday at 3pm and License/Ordinance meeting will be Thursday at 4pm. She advised where the citizens can now find the latest ordinances on the website, thanked the Clerk and Derrick for getting this done. Provided her phone # and email.

The mayor thanked Chief Malley and DC Bollinger for their help in getting the family on Central Park out of the fire. All donations can go through Ms. Gosa or the block club presidents.

Trustee Collier – Public works, the reports are in the back for citizen review. Keep up the good work on the grass cutting and the demolition.

Water-Great work being done by the water department, especially with the water main breaks.

Trustee Maxey – Public Property. He asked the mayor to report on what transpired with Dr. Mullins and the development project. Robbins' residents and developers included first; goal is to bring wealth to the people. Looking to move the open-air market back to Homan.
