 - A. Mayor's Report-Village is moving forward. Met with Governor Pritzker and was able to speak to him concerning the water bill and the City of Chicago and is very hopeful. Met with Representative Bob Rita and working to get on the same page for the Village needs. Next meeting will be with both the Senator Emil Jones and Representative Rita together. This helps to coordinate with our lobbyist efforts to build on what we need and make strides toward rectifying the problems in Robbins. Meeting date with State Representative and State Senator is to be determined. The new building director is Mr. Gerald Stewart. MWRD is scheduled to have another meeting in March on 3-21-22. By the end of March solidify bidder and end of April to break ground. Far from over with this project, we still have many meetings to happen with project to ensure it's done all the way through with Robbins in the forefront. Will bring MWRD out, want to continue to have public meetings. Robbins United breakfast March 5, to bring all Village entities together to talk about unified visions and goals. I hope to have a lobbyist there. Meeting is not open to the public.

- B. Clerk's Report- Municode process underway, getting tax bills in order, and many intergovernmental changes are being made. Trustee Robinson asked if any new business license applied for license and check with current businesses to make sure they are complying. Met with Mr. Stewart on that and have a list so that fees can be updated.

IV. STANDING COMMITTEE REPORTS

Trustee Robinson wants to propose citizens birthday shoutout in newsletter. At committee of the whole, flock safety camera update, we have 29 officers and our first CSO officer. Spoke to Senator Jones on Sunday, will meet with Representative Justin Slaughter Saturday morning. There will be a chili and toiletry give away on Feb. 26, at 135^{th &} Trumbull from 2:30pm until exhausted. Trustee Jackson asked about street signs and suggested that a survey be conducted to assess all signs that need repairs and updates. Fire hydrants also need to be addressed.

Trustee Robinson read Fire report from D.C. Malley-In the month of January there were 132 incidents: 104 fire related, 12 motorcycle, 5 hazardous. Still working to get smoke detector program. CDS came to assess electronic needs. Department striving to provide the best service possible.

Police Chief-There was a fight between two female students on Hendricks, working to resolve and place student in safe environment. Currently 29 employees are in the police department. Found vendor to invoice for repairs of vehicles. Working with Richard Flowers Homes for changes over the summer will give more details once solidified. Met with a retired state trooper on possible contract work as a truck and traffic officer to help bring in revenue. Working on prisoner daily charge for housing inmates of other agencies. Cadets are doing well in the academy. Spoke with Axon on cameras and tazers and representative will be coming soon to present. Latina Gee is the new CSO officer from Robbins, working with police department until she starts at the academy in August. Flock cameras update working very well, have aided to recover stolen vehicle, missing persons, and home burglary investigations.

Trustee Collier- stated that cut off notices will be sent out due to need of assistance from Bremen Township. Information on assistance is available to residents. Public works is working towards being better and more efficient. Was able to get better salt to help with ice melt, with the help of Trustee Brewton.

Trustee Dyson – Building-We have a new building director, Gerald Stewart. There will be a meeting Tuesday March 1, 2022 at 5pm to discuss new building code, fees, and permit updates.
