VA- Currently restructuring and redeveloping processes working on budgeting the mayor's vision, looking at what's coming in and going out to make a more accurate appropriation.

# IV. STANDING COMMITTEE REPORTS

Trustee Robinson- 8<sup>th</sup> month in seat, appreciate the residents calling about issues, and bringing issues to her please email concerns to <a href="mailto:Trobinson@robbins-il.com">Trobinson@robbins-il.com</a>, thanks to citizens that keep informed about public safety. Please check filters and smoke detectors if any issues with service please let it be known. Call 911 with shootings to record and have data. Actively seeking grants for police dept. Thanksgiving dinner served to Fire and Police department. Saturday 10-12pm shop with a cop event, we were gifted \$1,000 and have \$3,000 to go shopping at Walmart. Walked fire house to go over necessary repairs.

Chief Sheppard- people that are accused of crimes are out of jail due to current bail laws and structure from states attorney. Solution to assist with keeping offenders of the streets are the purchasing of the 8 360-degree cameras to catch crime as is happens. Finley needs 6 high speed bumps. Flock cameras that are used to read license plates is used as a tool to assist in solving some recent shooting incidents and was able to recover the vehicles involved. We are diligently trying to work with State Attorney office; Deputy Chief went and asked Tim Evans (Circuit Judge) what's going on with policy of low bonds, resulting in offenders being released soon after being arrested. Want to work with block clubs to help solve issues. New juvenile detective has been hired. We face a problem in the Police department, the pay and benefits are not marketable to officers that are already trained and we are working to get higher wages. The Academy was full, and the enrollment isn't until next in May. September is the soonest we can get full time officers trained in the Academy, resulting in 9 new recruits unable to be trained until 2023. Please all residents in the VOR if you see a crime call 911. There is never a time that the police are staffed with one officer. If there is staffing issues, we will lean on the support of the Cook County Sheriff, in emergency situations they will patrol for us and leave when we recover. Will explore the option of having the gun return program. Please reach out to the Chief and Deputy with any concerns. Trustee Maxey asked to explain dispatch system. Chief explained.

Trustee Collier- Public works -Thank you to the water department with getting things on the right track. We are working to find leaks, thank citizens for keeping up on water payments. Public works working on winter budget and program, we are pleased with the direction we are heading with less complaints.

Trustee Brewton- Public property – With land acquisition, we are working with attorney to locate all Village owned parcels. If there are any issues with rat infestation, please continue to make reports pest control will respond. Finance meeting discussed the need for servers and is an emergency topic to be discussed. Adjacent land program may not roll out until next year approximately 1200 parcels but also must make payments arrangements to attorney for previous work from prior administration.

Look for planning and zoning to re zone. Step out on faith believe this is the right thing to do. We don't have 12million to complete project ourselves. Questions were answered by MWRD. Trustee Collier- wants to move forward and are on a time basis the parcels we are in jeopardy of losing parcels and VOR can lose more land.
