Trustee Collier- Water Notices for shut-off of services have been issued and sent out, call in to set up a 6 month payment plan. Working on an ordinance for all residents to have Robbins water meters. There is \$4 million dollars in DECO grant for water infrastructure. A list has been given to Mr. Stroger and Mr. Kemp of all the repairs that qualify for the grant. Initial focus will be on water main break problem areas. Public Works has collected \$2,400 from approved items that were disposed and funds will be filtered back into the department. Mr. Wells is working on a tree trimming program for the Village and residents starting tentatively next month. Trustee Brewton- a citizens requested Warrant list please contact after the meeting to obtain a copy. Citizens have expressed concern regarding land acquisition and there will be a Public Property meeting soon, date to be determined. Looking at next Tuesday 3:30. IML conference learned about a Push tax of a penny per push on gaming machines, has substantial increase with just a small change.

- VI. NEW BUSINESS
  - A. Approval of purchasing of safety cameras from PDC

    Mayor recommended to table due to financial contract not being received.

    Payments for cameras is estimated to be \$40,000 with payment arrangements being between 12-18 months. If arrangement for 12 months is considered payments will be \$4,255.06/month, if arrangement for 18 months payments will be \$2,863.55/month. Trustee Dyson motioned to table approval of payment for purchase of safety cameras from PDC until next scheduled special meeting seconded by Trustee Collie. Trustee Brewton asked if cameras are 360. The proposal is for 8 additional cameras that have 360 parameter view, and the total cost is \$49,178.88. Cameras will be placed to help with eyes for recent crimes in the community.

B. Approval of Flock Safety Cameras for a 60-day trial period.

To answer the question of what is the 30- day payment after receipt of invoice; it is a full one- time payment of \$22,000 due after 60- day trial period, that automatically begins on the 60<sup>th</sup> day. Flock safety is a company that offers cameras that specialize in license plate readers. A hot list was created, and the data can be shared throughout different municipalities. Posen has reached out to see where we will place cameras to ensure that all areas shared can be strategically placed. Flock has suggested to share cost with Kellar School, there is a grant Safe Route to School that can help offset cost for the purchase of the cameras. Proposal is for eight cameras and the data is what is purchased, suggest a close monitor of cameras to see effectiveness 15-day, 30-day and 45-day analysis. Trustee Jackson motioned to approve the 60-day trial period seconded by Trustee Collier.
